Three-year full-time graduates from BCom, BA, BAF, BBI, BBA, BBE, BFM, BHRM, BIBF, BBM, BMS, BSc (Maths, Physics, Chemistry, Botany, Biology, Zoology, Life sciences, Biochemistry, Biotechnology, Microbiology, Environmental science, Geology, Hospitality, Tourism management) with 2027 as the year of completion.

Courses & Discipline: 3 year full-time graduates from BCom, BA, BAF, BBI, BBA, BBE, BFM, BHRM, BIBF, BBM, BMS, BSc (Maths, Physics, Chemistry, Botany, Biology, Zoology, Life sciences, Biochemistry, Biotechnology, Microbiology, Environmental science, Geology, Hospitality, Tourism management) – 2027 year of passing can only apply.

- **Course Types:** Only full-time courses will be considered (part-time / correspondence courses will not be considered). Candidates who have completed their Secondary and / or Senior Secondary course from NIOS (National Institute of Open Schooling) are also eligible to apply if the other courses are full-time.
- **Highest Qualification:** It is mandatory that the course to be cleared and completed within the stipulated time duration of the course without any backlogs to be eligible for joining in TCS if selected.
- **Backlogs & Extended Education:** One active backlog at the time of appearing for the TCS selection process is permitted. **However, it is mandatory that the course is cleared and completed within the time duration stipulated by the University without any backlogs for a candidate to be eligible to join TCS, if selected. Extended Education will not be considered as eligible.**

- **Gap / Break in Education:** It is mandatory for students to declare gaps in education, if any in TCS Application Form. The overall academic gap should not exceed 24 months until the highest qualification. Relevant document proof, as applicable, will be checked for gaps in education.
- **Work Experience:** Please note, the role is for 'Entry Level Requirement'. However, prior work experience, if any is required to be mandatorily declared by the candidates in the TCS Application Form.
- **Age:** Minimum age – 18 years and Maximum age – 28 years.

Steps to complete the Application Process:

Step 1. Registration Process

- Visit [TCS Next Step Portal](#)
- Click “**Register Now**”
- Select category as “**BPS**”
- **Fill the Candidate Registration Form to generate a Reference ID**

Step 2. Details in application form

- It is mandatory to update:
 - Name as per Aadhaar card.
 - Date of birth as per Aadhaar card.
- Please check the details are updated correctly before submission.
- Incorrect details submitted may lead to disqualification of your candidature.

Step 3. Register and apply for the TCS BPS Hiring process for **Batch of 2027**.

Important: Please ensure that the details in the TCS Application Form are complete and accurate (Academic Details, Internship, Work Experience, if any)

Step 4. Select your mode of test as 'In-centre' and choose your preferred test centre & then click on **Apply**.

Please note, test centre once chosen cannot be changed.

Step 5. To confirm your status, check '**Track Your Application**'. The status should reflect as '**Applied for Drive**'.

NOTE: To complete the TCS BPS NQT 2027 Hiring registration process, candidates must register, fill out the application form, and click on “Apply for Drive.” A candidate will be considered for this hiring process only after successfully clicking on “Apply for Drive” and the application status reflects “Applied for Drive.”

Kindly note that we have a stringent eligibility criterion and a robust selection process. Your eligibility as per the defined criteria will be checked at various stages of the selection process. At any point of time if you are found ineligible, or data shared by you is found discrepant, your candidature will be disqualified.

Students must register and fill up the application form on the TCS Nextstep portal under BPS. The status should reflect as '**Applied for Drive**'. To be eligible for Test process. Only students with this status will be eligible to participate in the test process.

Please note that this is an In-Centre Test. Seats at the respective test centers will be allotted subject to seat availability and are expected to fill up quickly based on the registration volume. Therefore, we strongly encourage you to register and apply at the earliest to secure your preferred test center.
